Introduced in Budget 2023, the "e-invoice" is a pivotal step towards advancing Malaysia's digital landscape, enhancing the digital tax service administration and collection. This implementation will take place in stages from June 2024, commencing with mandatory adoption by businesses boasting an annual turnover surpassing RM100 million. The oversight of this implementation will be done by the Inland Revenue Board of Malaysia (HASiL), in collaboration with the Malaysian Digital Economy Corp (MDEC), to ensure a seamless and successful rollout.
